

## **PRIVACY NOTICE PUPILS**

You have a legal right to be informed of how Ambitions Academies Trust (AAT) collects, stores and uses personal data relating to pupils. AAT is committed to being transparent about how it collects and uses the data and to meeting its data protection obligations.

To comply with this AAT and Longspee Academy provides you with a privacy notice to explain how it collects, stores and uses your personal data.

### **1. What information does AAT collect?**

AAT collects a range of information about you. Some of the information will come from other places such as other schools, the Local Authority and the Government. This includes:

- Your name, address and contact details including email and telephone number;
- Your test results;
- Your attendance records;
- Your characteristics, like your ethnic background or any special educational needs;
- Any medical conditions you have;
- Details of any behaviour issues or exclusions;
- Photographs;
- CCTV images.

### **2. Why does the organisation process personal data?**

AAT uses this data to help run the Academy including to:

- Get in touch with you and your parents when the Academy needs to;
- Check how you are doing in exams and work out whether you or your teachers need any extra help;
- Track how well the Academy as a whole is performing;
- Look after your wellbeing.

### 3. The lawful basis on which AAT processes this information:

AAT and Longspee Academy will only collect and use your information when the law allows them to. Most often, AAT and Longspee Academy will use your information where they:

- need to comply with the law;
- need to use it to carry out a task in the public interest (in order to provide you with an education);

Sometimes, AAT and Longspee Academy may also use your personal information where:

- You, or your parents/carers have given AAT and Longspee Academy permission to use it in a certain way;
- AAT and Longspee Academy need to protect your interests (or someone else's interest).

Where AAT and Longspee Academy have got permission to use your data, you or your parents/carers may withdraw this at any time. AAT and Longspee Academy will make this clear when they ask for permission, and explain how to go about withdrawing consent.

Some of the reasons listed above for collecting and using your information overlap, and there may be several grounds which mean they can use your data.

#### **NHS Track and Trace – COVID-19**

The law on protecting personally identifiable information allows Public Health England to use the personal information collected by NHS Test and Trace Service. If required to do so, Ambitions Academies Trust will provide contact details of all children and adults that have been in close contact with anyone that has tested positive for Covid-19 within Ambitions Academies Trust settings.

This is in accordance with Article 6(1)(e) of the GDPR '*processing is necessary for the performance of a task carried out in the public interest*'. For more information please see the following government guidance.

### 4. Collecting this information:

Whilst the majority of information you provide to AAT is mandatory some of it is provided on a voluntary basis. In order to comply with data protection legislation AAT will inform you whether you are required to provide certain school workforce information or if there is a choice.

### 5. How does AAT protect data?

AAT takes the security of your data seriously. It has internal policies and controls in place to ensure that your data is not lost, accidentally destroyed, misused or disclosed and is not

accessed except by AAT employees in the proper performance of their duties. Appropriate restriction levels are in place in management information systems where your data may be held.

AAT will not transfer your data outside the European Economic Area.

- The Local Authority
- The Department of Education (DfE)
- Ambitions Academies Trust

## 8. Why AAT share pupil information:

AAT and Longspee Academy do not share information about its pupils with anyone without consent unless the law and AAT policies allow this. AAT share pupils' data with the DfE on a statutory basis. This data sharing underpins school funding and educational attainment policy and monitoring.

AAT and (insert name of Academy) are required to pass information about pupils to the DfE under regulations 4 (for PRU pupils) and 5 of the Education (Information About Individual Pupils) (England) Regulations 2013.

## 9. Data collection requirements:

- **Youth Support Services**

Once pupils reach the age of 13, AAT also pass pupil information to the Local Authority and/or provider of youth support services as they have responsibilities in relation to the education or training of 13-19 year olds under Section 507B of the Education Act 1996.

This enables them to provide services as follows:

- Youth support services;
- Careers advisers.

A parent or guardian can request that **only** their child's name, address and date of birth is passed to their Local Authority or provider of youth support services by

informing the Academy. This right is transferred to the child/pupil once s/he reaches age 16.

- **National Pupil Database (NPD)**

The NPD is owned and managed by the DfE and contains information about pupils in schools in England. It provides invaluable evidence on educational performance to inform independent research, as well as studies commissioned by the DfE. It is held in electronic format for statistical purposes. This information is securely collected from a range of sources including schools, local authorities and awarding bodies.

We are required by law, to provide information about pupils to the DfE as part of statutory data collections such as the school census and early years' census. Some of this information is then stored in the NPD. The law that allows this is the Education (Information About Individual Pupils) (England) Regulations 2013.

The DfE may share information about pupils from the NPD with third parties who promote the education or well-being of children in England by:

- Conducting research or analysis
- Producing statistics
- Providing information advice or guidance

The DfE has robust processes in place to ensure the confidentiality of data is maintained and there are stringent controls in place regarding access and use of the data. Decisions on whether DfE releases data to third parties are subject to a strict approval process and based on a detailed assessment of:

- Who is requesting data
- The purpose for which it is required
- The level and sensitivity of data requested
- The arrangements in place to store and handle the data.

To be granted access to pupil information, organisations must comply strict terms and conditions covering the confidentiality and handling of the data, security arrangements and retention and use of the data.

You also have the right to:

- object to processing of personal data that is likely to cause, or is causing, damage or distress
- prevent processing for the purpose of direct marketing
- object to decisions being taken by automated means
- in certain circumstances, have inaccurate personal data rectified, blocked, erased or destroyed; and
- claim compensation for damages caused by a breach of the Data Protection regulations
